

BYLAW 23-2005

A BYLAW OF STRATHCONA COUNTY IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF AMENDING THE FOXBORO AREA STRUCTURE PLAN BYLAW 90-90.

WHEREAS it is deemed advisable to amend the Foxboro Area Structure Plan Bylaw No. 90-90;

NOW THEREFORE, the Council of Strathcona County, duly assembled, pursuant to the authority conferred upon it by the *Municipal Government Act, R.S.A. 2000, c. M-26*, and amendments thereto, enacts as follows:

1. That this Bylaw is to be cited as the Foxboro Area Structure Plan Amendment No.3.
2. That Bylaw 90-90, as amended, be amended as follows:
 - 2.1 That Section 4.3 Multiple Unit Residential be deleted in its entirety.
 - 2.2 That Figure 4.0 - Foxboro ASP Amendment be deleted and replaced with Figure 4.0A attached re-designating a portion of NE 25-52-23-W4, Block B, Plan 802 2694 and SE 36-52-23-W4 from Low Density Multiple Residential to Single Unit Residential.
 - 2.3 That Figure 5.0 - Linkages be deleted and replaced with Figure 5.0A attached re-designating a portion of NE 25-52-23-W4, Block B, Plan 802 2694 and SE 36-52-23-W4 from Low Density Multiple Residential to Single Unit Residential.

Read a first time this 19 day of April, 2005.

Read a second time this 19 day of April, 2005.

Read a third time and finally passed this 19 day of April, 2005.

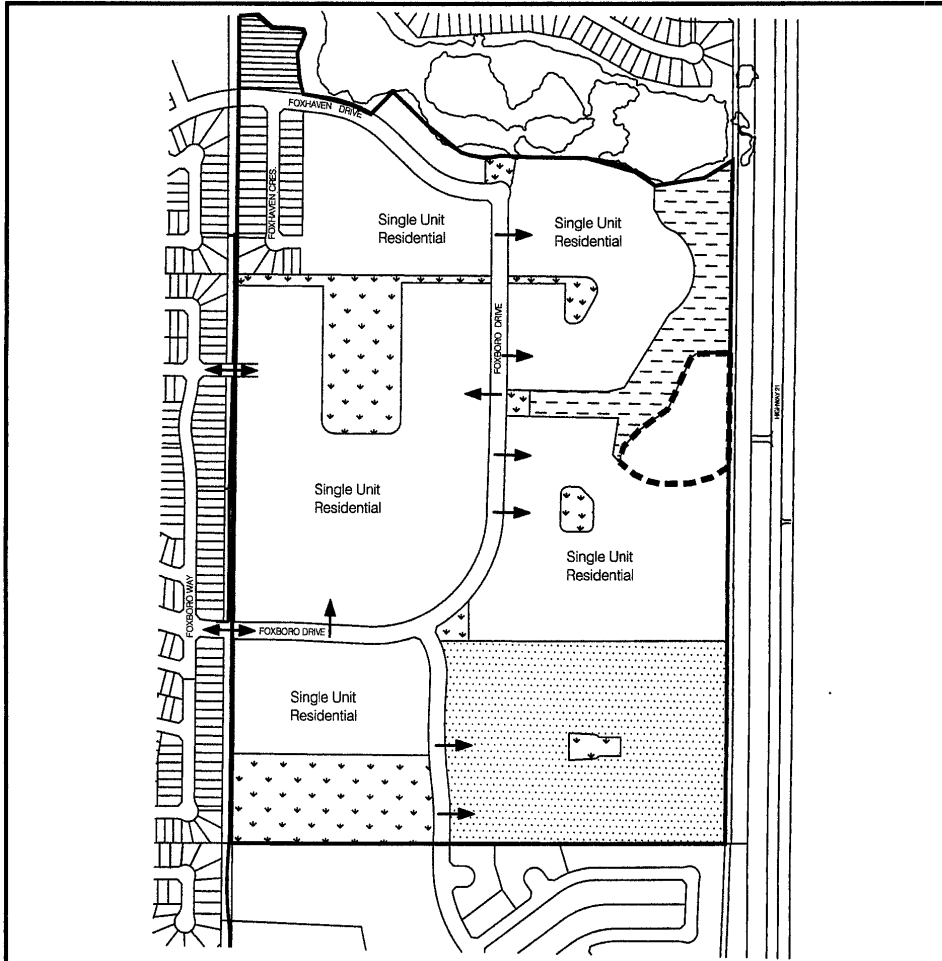






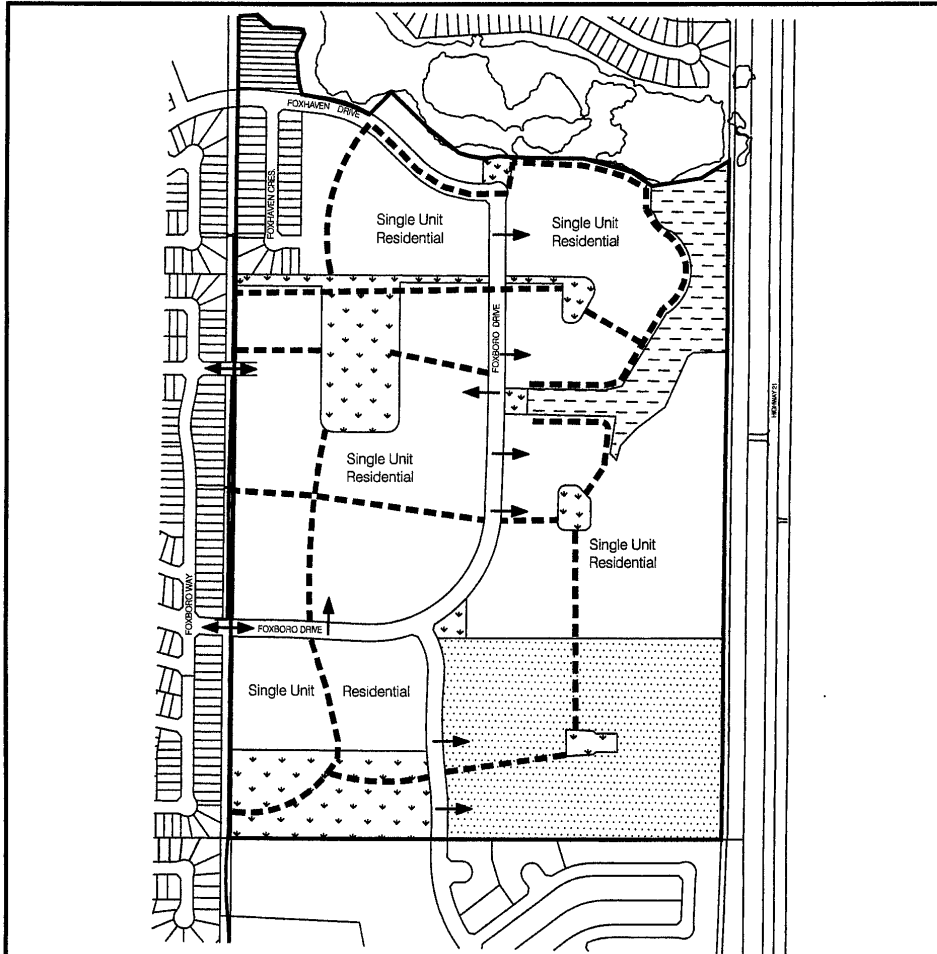

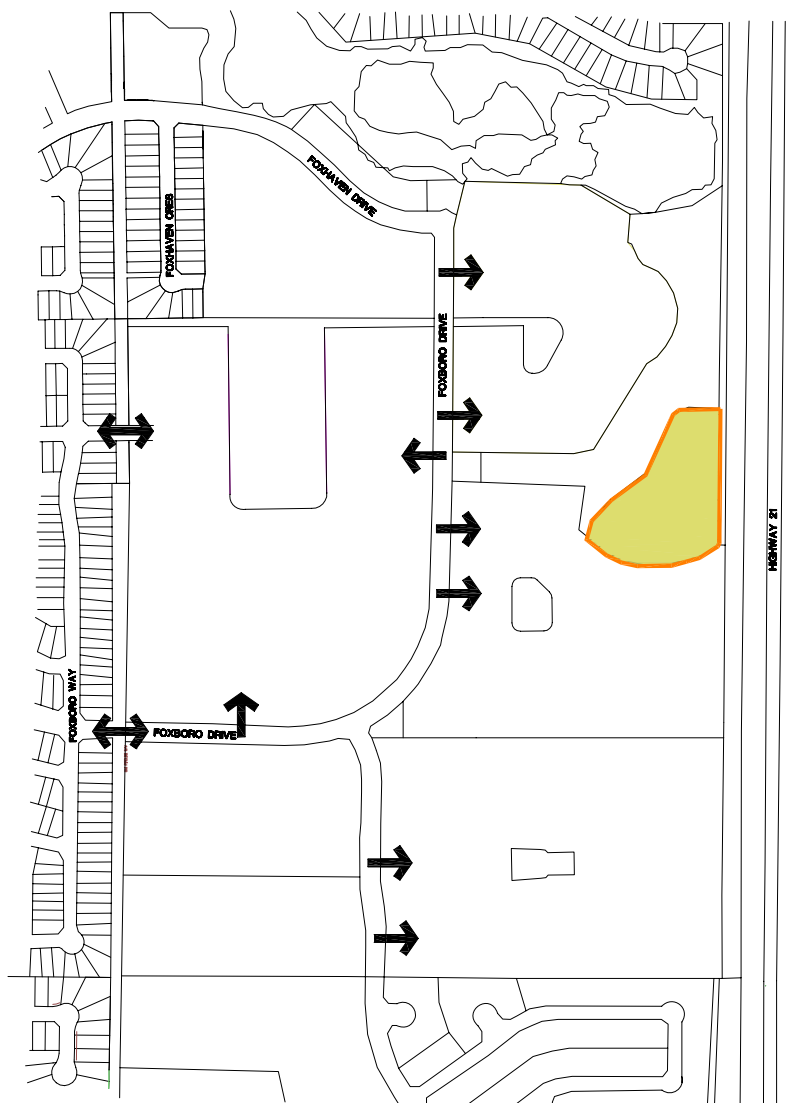
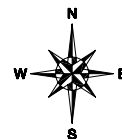
