I. Introduction and Overview of this Report

This report presents the results of the Strathcona County Census¹ that was conducted on May 1st, 2015. An up-to-date census count helps the County obtain federal and provincial funding that goes toward services for residents. The census count serves as a foundation for planning new community services and enhancing existing ones. Without the correct census information we cannot plan community projects such as schools, libraries, police stations, health and childcare, and transportation. An accurate count reflects the growth of the County and ensures that maximum per capita grants are received. Participation in the census by Strathcona County residents was voluntary.

The census data is also important to businesses that operate throughout the County. The information contained in this report can assist businesses in deciding where to locate factories, shopping centers, movie theaters, banks and offices -- activities that often lead to new jobs while enhancing the quality of life in Strathcona County.

Residents had the option of answering the census on-line, rather than being interviewed. Overall, 51.4% of County households used this option. The remaining 48.6% either contacted the Municipal Census office by telephone to complete the survey or were interviewed at their homes by one of the census enumerators.

Questions asked in the 2015 census include the following:

- Population numbers and distribution within Strathcona County
- Aspects of dwellings within Strathcona County as of May 1st 2015 (including type of dwelling, vacant vs. occupied status, number of dwellings under construction, ownership status and location of dwellings)
- Enumeration area breakdowns
- Length of residency
- School residency of residents
- Citizenship status
- Gender & year of birth of residents
- Marital status
- Employment or student status

Strathcona County conducts a municipal census in years when a Municipal Election or a Federal Census does not occur.



The data presented in this report presents overall totals for Strathcona County, as well as geographic breakdowns for:

- The urban service area (which is classified as Sherwood Park); and
- The rural portion of Strathcona County (other geographic areas in the county, which includes farms, country residential communities and other hamlets).



II. Results

A. Population Breakdowns

- The total population in Strathcona County was 95,597 in 2015. In 2012 there were 92,403 people and 87,998 people resided in the County in 2009.
- There has been an increase of 3,194 people in Strathcona County since the 2012 census, which is a growth of 3.5% over 3 years.
- The population distribution for the rural and urban portions of Strathcona County in the year 2015, along with 20012 statistics is shown in Figure 1.

(2015 and 2012 Comparisons)





Other Census Highlights - Population

- In Sherwood Park, the population has increased by 3,317 people, which is a 5.1% increase from 2012. There are now 68,782 people living within Sherwood Park as of 2015.
- Between 2012 and 2015, the population in rural Strathcona has decreased by 123 people, which is a 0.5% drop since 2012. The 2015 rural population total is now 26,815.




• A breakdown of population within the rural hamlets of Strathcona County can be seen in Figures 2a and 2b below. Due to redefinition of hamlet boundaries, no comparisons are done between 2015 and 2012.





- Overall, of the 26,815 residents living in Rural Strathcona, 2,001 live in the 8 hamlets noted on the previous page, 23,203 live on country residential estates and 1,611 live on farms (which include Hutterite colonies).
- A visual depiction of the changing size of Strathcona County since 1961 is shown in Figure 3. It can be seen that the size of the County has increased dramatically since 1961. The County has essentially doubled its size since 1981. Within the last 15 years (since 2000), it has increased in size by 38%.

Population Growth in Strathcona County (1961 – 2015)




B. Dwelling Statistics

Number of Dwellings

In 2015, the total number of dwellings in Strathcona County is 36,071. The total number of dwellings in the rural and urban portions of Strathcona County is depicted in Figure 4. The numbers shown in this figure is the combined total of occupied dwellings, vacant dwellings and dwellings that were under construction as of May 1st 2015.

Census Highlights - Dwelling Location

- This table presents a breakdown of the number of occupied and vacant dwellings throughout Strathcona County as of May 1st 2015. The percentages in this table depict the percentage comparison of the number of dwellings in the urban and rural regions of Strathcona County. For example, of the 34,793 occupied dwellings in the County, the majority of them (N=25,489 or 73.3%) are located in Sherwood Park.
- The other two columns depict breakdowns of the number of vacant dwellings and the number of dwellings under construction. The percentages add up to 100% in each column.
- The majority of dwellings that exist throughout the County are occupied. As seen in Figure 5 on the next page (and in Table 2 on page 9 of this report), it can be seen that for the County as a whole, 96.5% of the dwellings are occupied,

² It should be noted that during the data collection process, although guidelines were provided on how to classify a dwelling, individual judgment calls were often made by enumerators as whether a dwelling was "vacant" or "under construction." In this regard, it is possible that some dwellings classified as vacant should instead have been classified as under construction, particularly in new neighbourhoods. There were also instances where enumerators may have classified properties that were under construction as "vacant lots" due to very little activity on the site. The number of vacant lots throughout Strathcona County is not included in our data calculations, but is available upon request.



^{**} Four of the vacant dwellings in Sherwood Park and 9 vacant dwellings in Rural Strathcona were non-residential structures.

2.3% are vacant, and 1.3% are under construction. A breakdown for Sherwood Park and Rural Strathcona can also be seen in Table 2.

Occupancy Patterns of Dwellings in Strathcona County (2015)



Census Highlights – Dwelling Location

- This table presents a breakdown of the number of occupied, vacant and dwellings under construction for Sherwood Park, Rural Strathcona, and the total county. The percentages in this table depict a breakdown within each part of the county. For example, within Sherwood Park, of all the dwellings, the majority (96.4%) **are occupied**, with a very small percentage either vacant or under construction. The percentage breakdown is very similar in Rural Strathcona.
- The other two columns depict breakdowns of the status of dwellings in rural Strathcona and for the County as a whole.

Table 3 presents a breakdown of the status of dwellings within rural Strathcona as of May 1st 2015.

With respect to the vacant dwellings, please note that 1 of the farms and 8 of the country residential properties were non-residential structures.

Census Highlights – Dwelling Location within Rural Strathcona

- Within the rural parts of the County, dwellings can be located on farms, in a country residence or in a hamlet. For example, of the 9,304 occupied dwellings in rural Strathcona, the majority of them (N=8,000 or 86%) are classified as country residences.
- The other two columns depict breakdowns of the number of vacant dwellings and the number of dwellings under construction in each type of rural classification.

Types of Available Dwellings

The type of dwellings available to people in Strathcona County is listed in Table 4, which include those dwellings that are vacant or under construction at the time of the census collection.

Census Highlights – Dwelling Types

- The majority of housing stock in all parts of Strathcona County is single detached dwellings.
- There are very few duplexes and apartments (and no row house developments) in any parts of rural Strathcona County. The majority of these types of dwellings are located in Sherwood Park.

³ Collective dwellings include structures such as *nursing homes, senior citizen homes, Hutterite colonies* and *homes for challenged people (e.g. those with Alzheimer's etc.)*. There are also a number of independent living apartments, where residents live in their own suite.



Ownership Status of Dwellings



Census Highlights – Ownership Status of Existing Dwellings

- The majority of dwellings in Strathcona County are owned (88.2%). This breaks down to an 85.8% ownership in Sherwood Park and 88.2% in Rural Strathcona.
- With respect to the total number of dwellings, there were 922 instances where the ownership of a dwelling was not stated by the resident(s), which amounted to 2.5% of all dwellings in the County.

Census Highlights – Ownership Status of Occupied Dwellings

- The majority of dwellings in Strathcona County are owned (89.2%). This breaks down to an 87.1% ownership in Sherwood Park and 94.9% in Rural Strathcona.
- With respect to the total number of occupied dwellings, there were 6 instances where the ownership of a dwelling was not stated by the resident(s).

C. Length of Residency

In 2015, residents were asked how long they have lived within Strathcona County. An overall breakdown of the length in time residents have lived in either Sherwood Park or Rural Strathcona is shown in Table 7.

Census Highlights - Length of Residence

- The majority of Sherwood Park and Rural Strathcona residents have lived in Strathcona County for 10 or more years.
- The length of residency for 3,369 residents was not reported. In Sherwood Park, this information was not known for 2,514 people and for Rural Strathcona, 855 people.
- Percentages add up to 100% by columns. The percentage figures in Table 7 exclude those people whose length of residence was not stated.

D. School Support

School Support in Strathcona County


Census Highlights – School Preferences

- This data is based on the type of school system supported by household residents.
- More residents support the public system over the Catholic system. For the County as a whole, 71,123 residents supported the public system, while 20,993 supported the Catholic system. School support was not stated by 3,109 residents.
- In terms of percentage comparisons of those who declared the school system, 77.2% of school support was public, while 22.8% was catholic.

E. Canadian Citizenship

The Canadian citizenship breakdown of Strathcona County residents for 2015 is shown in Figure 8 by location of resident.

Census Highlights - Canadian Citizenship

- Most residents in both Sherwood Park and Rural Strathcona County are Canadian citizens. For the County as a whole, 88,839 residents are Canadian citizens, while 3,153 are not.
- Canadian citizenship status was not known for 3,233 residents.

Census Highlights - Household Size

- Percentages shown in this table add up to 100% by columns.
- The data presented in this table is based on occupied households that are classified as private households. A private household is defined as either a single person, a family with two or more persons, or a shared accommodation arrangement (e.g. two or more non-related people sharing a dwelling).
- This table includes those people living within collective dwellings. A collective dwelling refers to a setting that fulfills a particular purpose or function within the community, most often in some form of assisted living. For example, collective dwellings in Strathcona County can be nursing homes, senior citizen homes, or homes for physically or mentally challenged individuals. Hutterite colonies in Rural Strathcona are also classified as collective dwellings.
- In 2015, there were 165 occupied residences classified as collective dwellings in Strathcona County.⁵ Of these, 11 of the collective dwellings had 10 or more people residing in them; the number of people residing within a collective

⁵ 158 of the collective dwellings were in Sherwood Park, while 7 were part of rural Strathcona.



⁴Collective dwellings were not excluded from the numbers noted in this table.

dwelling range ranged from 1 person to 186 people. Many of the larger collective dwellings consisted of individual apartments where seniors lived independently.

- The average household size (excluding those living in *collective dwellings*) in Sherwood Park is 2.67 people. Since in reality we cannot have a portion of a person living in a household, in Sherwood Park, the median household size⁶ is 2 people.
- The average household size in Rural Strathcona is 2.87 people. The median household size is 2 people.
- A breakdown of household size within Rural Strathcona is as follows:
 - ➤ Country residential households have an average size of 2.90 people, with a median of 2;
 - Farms have an average size of 2.92 people, with a median of 2; and
 - ➤ Hamlets have an average size of 2.52 people, with a median of 2.
- The reason that collective dwellings are excluded from the calculation of average household size is that the number of people in these settings is often large, and will distort the average household size figures.

The median is the middle score, or the 50th percentile point of the distribution of households. What this means is that 50% of the households in Sherwood Park are above the median (or have more than 2 people), while 50% of the households are below the median (or have less than 2 people).



G. Gender & Age

Gender Comparisons

A breakdown of gender within Sherwood Park, Rural Strathcona, and Strathcona County as a whole is shown in Figure 8.

Census Highlights – Gender

- There is a fairly even split of males and females in all parts of Strathcona County. There are slightly more males in Rural Strathcona and slightly more females in Sherwood Park.
- In Sherwood Park, there were 461 instances where the gender of a household member was not stated. In Rural Strathcona, there were 255 instances where this information was not stated.

These shortfalls are either due to circumstances where there was no one available in a household to interview or where limited information was provided during the census data collection period. This is why the total of males and females is less than the total number of people noted earlier in this report. The same reason also applies to age, as there was no age information provided for 2,634 Strathcona County residents.



Age Comparisons

A breakdown of age within Sherwood Park, Rural Strathcona, and Strathcona County as a whole is shown in Table 9.

Census Highlights – Age

- A percentage comparison of age groups between rural and urban Strathcona reveals a similar distribution across the County in most age groups.
- In 2015, the average age of Sherwood Park residents is 38.5 years, while the median age is 39. In 2012, the average age was 37.9 and the median age was 38. What this means is that in the year 2015, the population in the urban center is growing slightly older. This aging trend has been occurring for some time now.
- In 2015, the average age of people living in Rural Strathcona is 40 years, while the median age is 43. In 2012, the average age was 39.2 and the median age was 43. What this means is that in the year 2015, the population in the rural areas is getting slightly older, much like the urban area.
- In terms of averages and medians derived in 2015, the people in Rural Strathcona are slightly older than those living in Sherwood Park. This has been a trend for several years now.

The age groupings depicted in Tables 10 through 11 correspond to Statistics Canada's age categories for easy comparisons. However, different age groupings of this data can be created upon request.



Census Highlights – Age by Gender

- Table 10 depicts a detailed percentage comparison of age groups by gender for Sherwood Park. With some minor exceptions, there are similar numbers of males and females within each age group. The main difference between the sexes can be seen within the 65-74 and 75+ age categories, where the females considerably outnumber the males. It should also be noted that 75+ age group has the smallest number of residents of all ages in the County.
- A further analysis revealed that the mean age for men in Sherwood Park was 37.8 years, while the mean age for females was 39.3 years. Median figures show the age midpoint for males being 38, and females being 39 years. The mean ages for males and females are slightly higher than what was found in 2012. The median age for males is one year higher than it was in 2012, while the female median age is unchanged from 2012.
- Table 11 depicts a detailed percentage comparison of age groups by gender for rural Strathcona. With some minor exceptions, there are similar numbers of males and females within each age group.
- A further analysis revealed that the mean age for men in rural Strathcona was 40.2 years, while the mean age for females was 39.8 years. Median figures show the age midpoint for males is 44 and females is 43 years. The mean ages for males and females are slightly higher than what was found in 2012. The median age for males is one year higher than it was in 2012, while the female median age is unchanged from 2012.

H. Marital Status & Family Status

A breakdown of marital status within Sherwood Park, Rural Strathcona, and Strathcona County as a whole is shown in Table 12.

Census Highlights – Employment Status

- In both Sherwood Park and Rural Strathcona County, the majority of residents are working full-time.
- In Sherwood Park, there were 2,255 instances where the employment status of a household member was not stated. ¹⁰ In Rural Strathcona, there were 809 instances where this information was not stated.
- Those classified as *not in the workforce* included residents aged 18 to 64 who were not in school and did not indicate that they were working either full time or part-time. The reasons why they were not in the workforce were not queried, which means that they could be homemakers, currently unemployed, retired, or are not able to work. Residents not in the workforce who are aged 65 or older have been classified as *retired*, but it is possible that a small portion of them would like to work if they could (and thus would be classified as unemployed), but there is no way of determining that for certain at this time.

Census Highlights – Employment Status by Gender

- Overall, it can be seen from Table 14 that across Strathcona County, considerably more males work full-time compared to females, while the proportion of females who work part-time is greater than males. This has been a trend for several years.
- A larger proportion of females are not in the workforce (compared to males), regardless of where they resided within the County.
- The work patterns based on gender show a similar pattern for residents who live in Sherwood Park (Table 15) and those who live in Rural Strathcona (Table 16).
- Percentages in each table add up to 100% by columns.


