All parking permits are the property of Strathcona County and must be surrendered upon request. 2. Permit is transferable between vehicles. 3. Reserved parking is only in designated areas, Monday to Friday, 5:00 a.m. to 6:00 p.m.. 4. Reserved parking is not in effect during special events, statutory holidays, weekends or evenings. 5. One Permit per stall. Vehicles improperly parked may be towed. Transit is not responsible for lost or stolen permits. 7. Parking permits are non-refundable. 8. Parking permits are void if altered or replicated. 9. Vehicles shall be carefully parked within and parallel to the striped lines of each stall, and shall be operated and parked in compliance of all signs and directions displayed in the parking areas. 10. Where stalls are provided with an electrical plug-in, the County will endeavour to provide service when temperatures drop below -15 C. **Permit and Parking Conditions** 1. All vehicles shall be parked at the sole risk of the owner and/or operator, and the County assumes no responsibility for any damage to or loss of vehicles or its contents. 2. The County, its officers, contractors, employees or agents shall not be liable at any time under any circumstances for any malfunction, failure or unavailability of any electrical, mechanical or other facilities or equipment in the parking areas, or for any loss, damage, expense or inconvenience of any nature, (either direct or indirect) resulting there from or related thereto. 3. Vehicles may be ticketed or removed at the owner's expense in the following instances: Displaying an altered or expired parking permit. Notes, handwritten or otherwise are not recognized. Vehicle is leaking oil/gas, or any other hazardous or noxious substances, or continuously sounding a vehicle alarm. Vehicle is a non-passenger vehicle or has a non-Passenger vehicle hitched to it. No trailers, boats, motor homes, large trucks (i.e. semis, RVs, etc). 4. In the event any damage or inconvenience is occasioned to or by reason of any motor vehicle being removed or towed away or impounded pursuant to these regulations by an independent contractor, neither the County, its officers, contractors, employees or agents shall be liable or responsible in any way whatsoever for such damage or inconvenience. 5.
