# Temporary Signs on Public Property

Includes Real Estate Directional Signs, Private Sale Sign, and Signs for a Community Notification.



#### **Permits**

A permit is not required for a real estate directional sign, private sale sign or a community notification sign provided that the sign complies with the Land Use Bylaw regulations.



#### Definitions

#### **Temporary Sign**

A sign erected for a specified period of time announcing or advertising an event of limited duration.

#### **Real Estate Directional Sign**

A temporary sign pertaining to the sale or lease of land or building, or a portion thereof, which is not placed on the land or building to which it relates. The message is restricted to the realtor's corporate name, the realtor's corporate logo, and brief directional information to the land or building to which it relates. It does not include any additional advertising including slogans.

#### **Community Notification Sign**

A sign used to display educational material and community events or notices.

#### Private Sale Sign

A sign advertising a private sale of an individual's personal property including house sales, garage sales, and rummage sales.

> Each sign must have the name, address and phone number of the sign owner.

A temporary sign on public property must be self supporting and will collapse upon impact unless it is paper, cardboard or other similar light materials.

A temporary sign on public property cannot exceed 1.1m2 in area and 1.2m in height.

Signs are not allowed on a public roadway, median, traffic circle, culde-sac or concrete island nor where they restrict sight lines or interfere with the safe movement of pedestrians or vehicles.

There are specific size, height, and location regulations for all types of temporary signs.

Only one temporary sign is allowed for each property frontage.

### Where can I post my sign?

On public land bordering streets in Sherwood Park. temporary signs are required to maintain a minimum of:

- 1 meter from the curb or edge of the roadway
- 3 meters from a site access
- 10 meters from any intersection
- 30 meters from an approved portable sign
- 10 meters from a permanent sign

### When can I post my sign?

#### Private Sale &/or Garage Sale

Signs are allowed for a period of 72 hours and may be posted 12 hours before the sale but must be removed within 12 hours after the sale.

#### **Real Estate Directional**

Signs may be placed during the following times:

- Monday to Thursday between 8:30 a.m. to 11:30 a.m.
- From 4:00p.m. on Friday till 8:00p.m. on Sunday (or holiday Monday)
- Signs relating to a real estate open house must be removed within 24 hours of the end of the event

Note: Incorrectly placed signs may be removed by Strathcona County and impounded at the Strathcona County Public Services Yard. A fee is applicable for retrieving a sign that has been impounded.
