

Vehicle for Hire Bylaw 30-2016

A safe ride for taxi, accessible taxi,
limousine drivers and passengers.

Taxi drivers must display:

- Vehicle for Hire permit on or within the vehicle in a location visible to all passengers, or the permit may be provided electronically through a mobile application.



The licence plate also counts as a display of the vehicle permit.

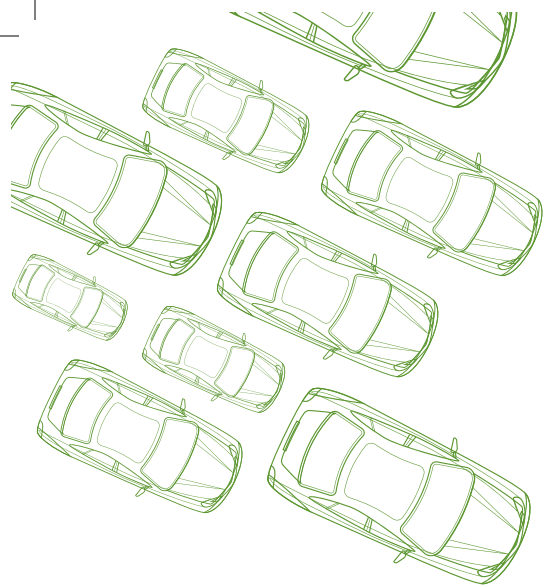

- The driver has a valid Driver's Permit
- Vehicles have regular mechanical inspection
- Permitted drivers passed an RCMP Criminal Record Check, RCMP Vulnerable sector check and have proof of insurance coverage.



Learn more about the Vehicle for Hire Bylaw in the County

The Vehicle for Hire Bylaw (30-2016) aims to ensure safety for both customers and vehicle for hire drivers.

The bylaw provides an important incentive for operating accessible taxis in Strathcona County by charging \$0 for accessible vehicle and driver's permit.

As of July 1, 2017, the new Vehicle for Hire Bylaw (30-2016) replaces the Taxi Cab Safety Bylaw (20-2013), due to significant changes in the vehicle for hire industry.

Vehicle for Hire permits

Taxis, accessible taxis and limousines, and their drivers must have a Vehicle for Hire driver's and vehicle permit to operate in Strathcona County.

Permit exceptions:

- Vehicle for Hire permits are not required for limousine and accessible taxis that have existing licence/permit/approval from another municipality that meets or exceeds the requirements of section 29 or 32 (as applicable) of Strathcona County Vehicle for Hire bylaw. Call Enforcement Services for more information at 780-449-0170.
- Drivers of Transportation Network Automobiles are regulated by the Alberta Transportation Network Companies Regulation (Alta Regulation 100/2016) and are not required to get a separate driver's permit in Strathcona County.
