

BYLAW 34-2017

BOARDS AND COMMITTEES HONORARIUM BYLAW

STRATHCONA COUNTY

WHEREAS:

- A. pursuant to section 1(1)(f) of the *Municipal Government Act*, RSA 2000, c M-26, a Council Committee is any committee, board or other body established by Council under the *Municipal Government Act*;
- B. pursuant to Part 5 of the *Municipal Government Act*, and in particular, section 145, Council may by bylaw established Council committees and prescribe rules for their conduct and procedure;
- C. pursuant to Part 11 of the *Municipal Government Act*, and in particular, section 454.1, Council must prescribe the remuneration and expense, if any, payable to appointed members of the Assessment Review Board;
- D. it is deemed advisable to prescribe honoraria payable to the members of Council Committees.

NOW THEREFORE, the Council of Strathcona County enacts as follows:

| Purpose | 2 | The purpose of this bylaw is to prescribe honorarium payable to certain members of Council Committees. |
| Interpretation | 3 | The headings in this bylaw are for reference purposes only. |
| Definitions | 4 | In this bylaw: <ul style="list-style-type: none">(1) "Council" means the elected governing body of the County;(2) "Council Committee" means a committee, board or other body established by Council under the <i>Municipal Government Act</i>;(3) "County" means the municipal corporation of Strathcona County; and |

(4) "*Municipal Government Act*" means the *Municipal Government Act*, RSA 2000, c M-26, as amended.

- Honorariums for Members** 5 Honoraria will be paid to members of certain Council Committees for serving as a member of those certain Council Committees in accordance with Schedule "A" to this bylaw.
- No Honorariums for Councillors Coming into Force** 6 Notwithstanding section 5 of this bylaw, honoraria will not be paid to Councillors serving on a Council Committee.
- 7 This bylaw comes into force on the 1st day of January, 2018.
