All multi-family buildings and complexes within Strathcona County must comply with Waste Management Bylaw 39-2014. This Bylaw states that a) waste disposal, and paper or cardboard recycling must be accessible to all residents and b) current levels of waste diversion efforts must be maintained or upgraded.

Strathcona County Utilities collects the information to confirm the bylaw is being adhered to, as well as to find out if there are any opportunities for education and improvement.
