# I. INTRODUCTION AND PURPOSE OF THE STUDY

In November 2018, Strathcona County conducted an online survey as part of its SCOOP initiative to obtain feedback from residents about different aspects of life in Strathcona County. This project, entitled the *Mixed Topic Survey*, consisted of different survey areas whereby only a limited number of questions were asked within one or more topic areas. The intent of the Mixed Topic Surveys was to run these monthly and exclusively to residents who signed up to be part of Strathcona County's Online Opinion Panel. November's mix topic survey consisted of questions pertaining to awareness of County Services, roadside signage in the County and the Pride of Strathcona awards.

Obtaining primary data from residents directly will provide Strathcona County departments with information, and enable County officials to make decisions that accurately reflect the perspectives and attitudes of residents. This report will provide a comprehensive review of all steps undertaken in the development and implementation of the survey, as well as a detailed summary of the results. The results from this study were prepared by Communications in December 2018; SPSS was used for the data analysis.

# II. METHODOLOGY

#### A. The Questionnaire

The questionnaire used in this study was a mixture of old and new questions, using questions that were submitted by department representatives from Communications, Transportation and Agriculture and Corporate Services. Using these questions, the survey was created, reviewed and modified where necessary by members of Survey Central for wording, question ordering and general understanding. This included a final check of the content by FOIP prior to the release of the survey to the public.

# B. Sampling Design and Data Collection Procedure

The sample frame used in this study consisted of 301 people who had previously signed up to be part of SCOOP, Strathcona County's online opinion panel. Overall, 76.1% of the participants lived in the urban area, 19.9% came from rural parts of



Strathcona County, and the remaining 4.0% worked in Strathcona County but did not live there.

The sample frame provided overall results<sup>1</sup> accurate to within  $\pm$  5.6%, 19 times out of 20. The data was gathered via the online SCOOP platform between November  $28^{th}$  and December  $10^{th}$  2018.

During the fielding of the survey, respondents had the option to skip a section if they felt that the topic had no relevance to them.

As seen in Figure 1, the majority of respondents who participated in the survey are over the age of 44, with approximately one third of the participants between the age of 25 and 44. Only a very small percentage of participants were under 25. Overall, 66% of participants were female while 34% were male.



The ± 5.6% is the *margin of error* associated with this study and refers to the potential percentage spread that exists within answers to particular questions. This means that an answer could be up to 5.6% higher or lower than what is reported. Please note, however, that the data was gathered though an online survey and no controls were undertaken to make this a random sample.

# III. 2018 SURVEY RESULTS: AWARENESS OF SERVICES

Strathcona County residents who lived in Sherwood Park or specific rural subdivisions, as well as those who worked in the County but did not live here were asked to answer a series of questions about their awareness of different Strathcona County services. The entire sample opted to answer questions on this topic. A measurement of awareness of County services was previously asked in the last two public satisfaction studies. A summary of the overall results to these questions is presented in Table 1, organized on the basis of the *very aware* rating

Overall, the majority of respondents had strong awareness levels of the *integrated* fire/medical aspect associated with Emergency Services. There was also a strong awareness of the Strathcona County Alert system (when the very aware/moderately aware figures were combined). There were considerably lower levels of awareness noted for the remaining aspects measured this year. In particular, there was no awareness of the Beaver Hills Biosphere or the Boards and Committee recruitment process by a large



majority of residents. The awareness percentages for <u>all of the services</u> noted in Table 1 were similar to when these were measured in 2017.

In this year's survey, one's age was a factor with respect to awareness levels for four of the items as noted below:

- With *Emergency Services being an integrated service*, being very aware of the service increased as the age of the individual increased.
- Being very aware of the *SC Alerts system* was highest among those aged 45-64 compared to those younger than 45 or older than 64.
- Being very aware of *Strathcona County's online tools for reviewing details about one's property or doing a breakdown of one's property taxes* was considerably lower among those aged 65 or older compared to younger people.

A summary of the percentage change between 2017 and 2018 for the items associated with measuring awareness of particular aspects of Strathcona County is shown in Table 2. It can be seen that increased awareness in the *very aware* module between 2017 and 2018 occurred for all of the items, particularly the *Strathcona County Alerts System* and for *Emergency Services being an integrated fire and emergency medical service*.

# IV. 2018 SURVEY RESULTS: CURRENT AND POTENTIAL HOUSING IN STRATHCONA COUNTY

Strathcona County residents who lived in Sherwood Park or specific rural subdivisions, as well as those who worked in the County but did not live here were asked to answer a series of questions about housing. This included the type of housing they currently lived in, whether they planned to move in the future, and things that they looked for in a neighbourhood, regardless of their future moving status.<sup>2</sup> Almost the entire sample (97.7%) opted to answer questions on housing.

Initially, respondents were asked to indicate the type of dwelling that they are currently living in. Of those who answered:

- 86.3% live in a single detached dwelling;
- 5.5% live in a duplex;
- 3.4% live in an apartment style dwelling;
- 2.6% live in a row/town house; and
- The remaining 2.1% live in a suite within a single detached dwelling, a manufactured home or a condo.<sup>3</sup>

Almost all respondents were homeowners (92.4%). The remaining respondents were either renters (5.3%) or an "other" (2.4%), which usually meant they were family members within a household.


A depiction of potential moving plans among respondents is shown in Figure 2. It can be seen that just over 25% had tentative plans to move within the next 5 years. The majority of respondents did not.

There is actually no unique definition of a condo, so it is likely that those individuals likely live in an apartment or a townhouse dwelling.




There were a small number of respondents who worked in the County but did not live here. A subsequent comparison of these people compared to those who lived in the County did not result in any significant differences.



A comparison of moving plans based on homeownership is shown in Figure 3. It can be seen that renters have a much higher potential for moving within the next 2 years compared to homeowners.

Respondents were then asked as to what type of housing they would move into should they decide to move in the future. Figure 4 depicts the type of housing that those currently living in single detached housing would choose to move into, as well as those in other types of housing. It can be seen that 49.2% of those currently living in a single detached dwelling would continue to do so. However, it can also be seen that many of them (23.5%) would choose to move into another type of dwelling, most often being

some sort of dwelling geared to seniors. The remaining current single detached dwellers would be looking to downsize into a duplex, row house or apartment.

It can also be seen from Figure 4 that 58.1% of those living in another type of dwelling would choose to move into a single detached type of home. There were also 22.6% who would move into another type of dwelling, again most often some sort of dwelling geared to seniors.



The next question in the survey asked respondents to indicate what factors would enter into their decision for a new home. It can be seen from Figure 5 that cost/affordability was the primary reason for moving into a new home, followed by the neighbourhood and proximity to services. Other factors also mentioned by 9.7% of respondents as "other" factors included the size of the home, the size of the garage, access to parks and other natural areas and the proximity to getting to work.

The final question pertaining to housing asked respondents whether they thought they could find their preferred housing somewhere in Strathcona County. Overall, 60.7% thought that they could, 10.3% said no, and the remaining 28.9% were not sure.

# V. 2018 SURVEY RESULTS: PRIDE OF STRATHCONA AWARDS

Strathcona County residents who lived in Sherwood Park or specific rural subdivisions, as well as those who worked in the County but did not live here were asked to answer questions pertaining to the Pride of Strathcona awards. Overall, almost all of the respondents (93.7%) opted to answer questions on this topic.

Initially, respondents were provided with the following information:

The Pride of Strathcona Awards is Strathcona County's annual awards program aimed at fostering pride in the community by recognizing citizens for outstanding achievements and contributions. Residents can be recognized in the following categories: Agricultural Leadership; Arts, Culture and Heritage; Community Service; Economic Diversification; Heroism and Leadership; Outstanding Group; Service to Seniors; and Youth.



The first question asked respondents if they were aware of the Pride of Strathcona Awards program prior to reading the information in the survey. Overall, 63.1% indicated that they were previously aware of the program. A further analysis revealed that:

- A greater percentage of females (67.4%) were aware of the awards compared to males (54.3%); and
- A greater percentage of older respondents (aged 45 to 64 71.4% and age 65 or older 71.9%) were aware of the awards compared to those under the age of 45 (46.3%).

Respondents were then asked if they would consider nominating someone for a Pride of Strathcona Award in 2019. Overall, 27% indicated that they would consider this. A further analysis revealed no differences in this based on gender or age.

Those who indicated that they would not nominate anyone were asked to state their reasons why they felt this way. Overall, the majority of them indicated that they had not lived in the County long enough or knew anyone that they could comfortably nominate for an award. There were some people who were not interested enough to go through the requirements to nominate someone, and there was one person who thought that that name of the award might confuse people who now associate the term pride with LGBTQ events. A list of the comments, grouped into categories, can be found on the next page.

## **Open ended comments on the Pride of Strathcona Awards**

#### **VI. 2018 SURVEY RESULTS: ROADSIDE SIGNAGE**

Strathcona County residents who lived in Sherwood Park or specific rural subdivisions, as well as those who worked in the County but did not live here were asked to answer a question about their awareness of various Strathcona County roadside signs. The entire sample opted to answer this topic question.

In the survey, respondents were shown a picture of the sign (depicted below) and then asked to indicate whether they recalled seeing it.





Overall, 77.3% indicated that they had seen it. A further analysis revealed no differences between gender nor age groups.
