I. Introduction and Overview of this Report

This report presents the results of the Strathcona County Census¹ that was conducted on May 1, 2018. An up-to-date census count helps the County obtain federal and provincial funding that goes toward services for residents. The census count serves as a foundation for planning new community services and enhancing existing ones. Without the correct census information we cannot plan community projects such as schools, libraries, police stations, health and childcare, and transportation. An accurate count reflects the growth of the County and ensures that maximum per capita grants are received. Participation in the census by Strathcona County residents was voluntary.

The census data is also important to businesses that operate throughout the County. The information contained in this report can assist businesses in deciding where to locate factories, shopping centers, movie theaters, banks and offices -- activities that often lead to new jobs while enhancing the quality of life in Strathcona County.

Residents had the option of answering the census online, rather than being interviewed. Overall, 51.8% of County households used this option.² The remaining 48.2% either contacted the municipal census office by telephone to complete the survey or were interviewed at their homes by one of the census enumerators.

Questions asked in the 2018 census include the following:

- Population numbers and distribution within Strathcona County
- Aspects of dwellings within Strathcona County as of May 1, 2018 (including type of dwelling, vacant vs. occupied status, number of dwellings under construction, ownership status and location of dwellings)
- Household Internet access and satisfaction with Internet speed (*new for 2018*)
- Number of vehicles in the household (*new for 2018*)
- Enumeration area breakdowns
- Length of residency
- School residency of residents
- Citizenship status
- Gender & age of residents
- Marital status
- Employment or student status
- Driver's license status (*new for 2018*)
- Volunteer status (*new for 2018*)
- Primary mode of transportation (*new for 2018*)

¹ Strathcona County typically conducts a municipal census in years when a municipal election or a Federal Census does not occur.

The data presented in this report presents overall totals for Strathcona County, as well as geographic breakdowns for:

- Sherwood Park, which is designated as the Urban Service Area in the remainder of this report; and
- The rural portion of Strathcona County (other geographic areas in the County, which includes farms, country residential communities and other hamlets). In this report, all of the rural components of Strathcona County are designated as the Rural Service Area.

Specific breakdowns for particular regions in the County, as well as different groupings of demographic data derived from the 2018 census (within reasonable limits) are available upon request. Strathcona County census data by ward, neighbourhood and subdivision is available, and other groupings of demographic data can be requested by emailing gismaps@strathcona.ca. 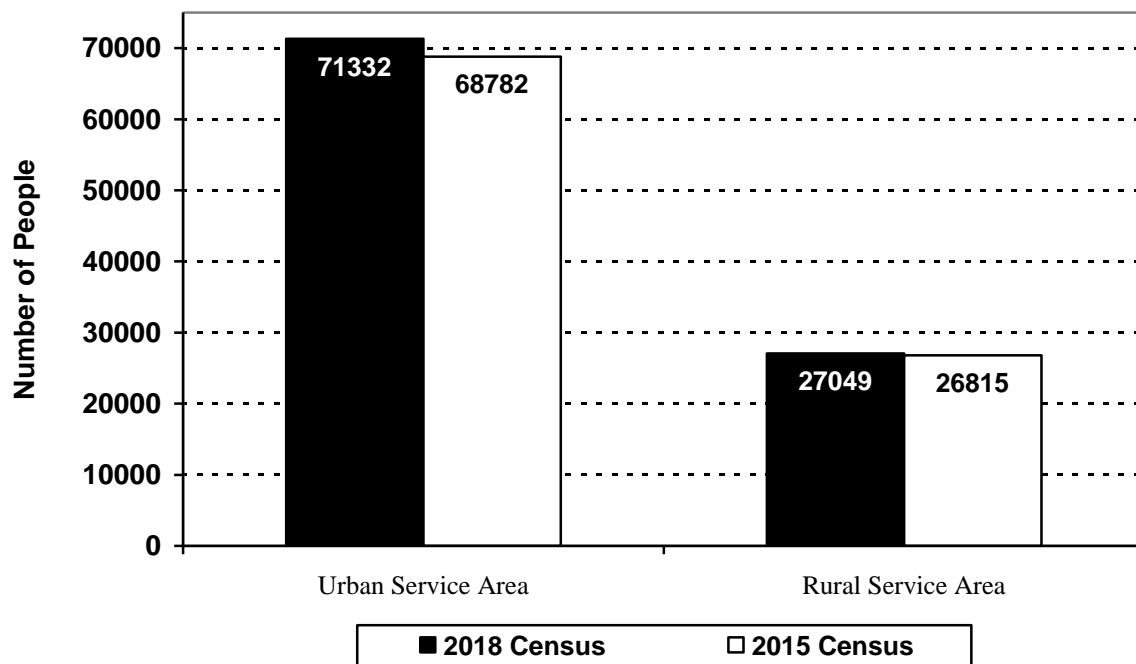
² The online participation was 0.4% higher than the previous (2015) municipal census.

II. Results

A. Population Breakdowns

- The total population in Strathcona County was 98,381 in 2018. In 2015, there were 95,597 people and 92,403 people resided in the County in 2012.
- There has been an increase of 2,784 people in Strathcona County since the 2015 census, which is a growth of 2.9% over 3 years.
- The population distribution for the rural and urban portions of Strathcona County in the year 2018, along with 2015 statistics is shown in Figure 1.

(2018 and 2015 Comparisons)

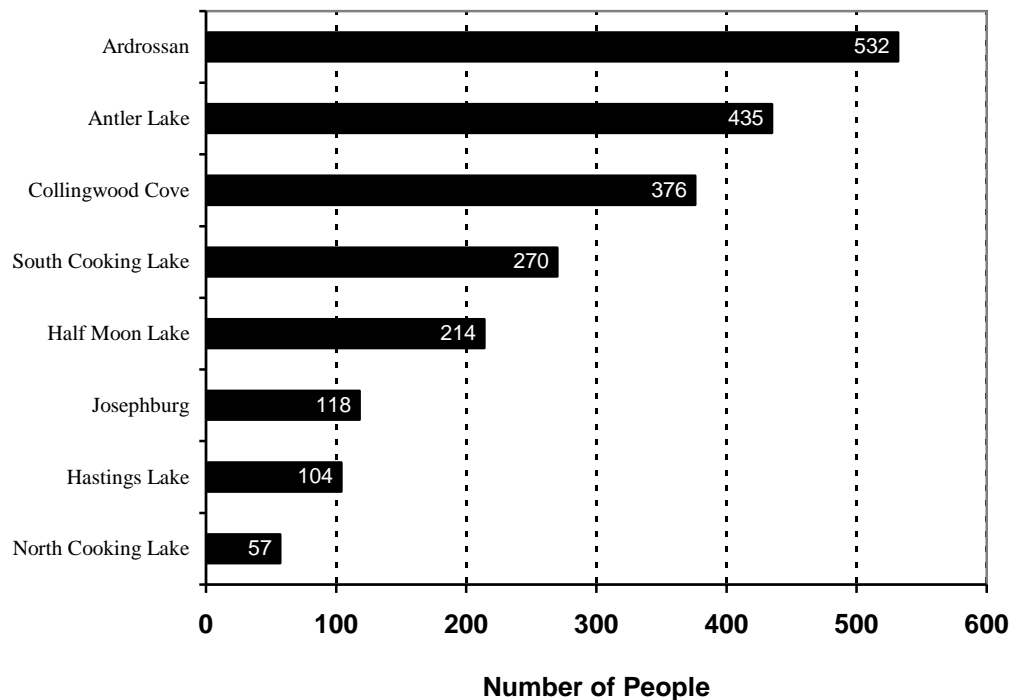


Other Census Highlights – Population

- In the Urban Service Area, the population has increased by 2,550 people, which is a 3.7% increase from 2015. There are now 71,332 people living within the Urban Service Area as of 2018.
- Between 2015 and 2018, the population in the Rural Service Area has increased by 234 people, which is a 0.9% increase since 2015. The 2018 rural population total is now 27,049.

- A breakdown of population within the rural hamlets of Strathcona County can be seen in Figure 2 below. Due to redefinition of hamlet boundaries, no comparisons are done between 2015 and 2018.

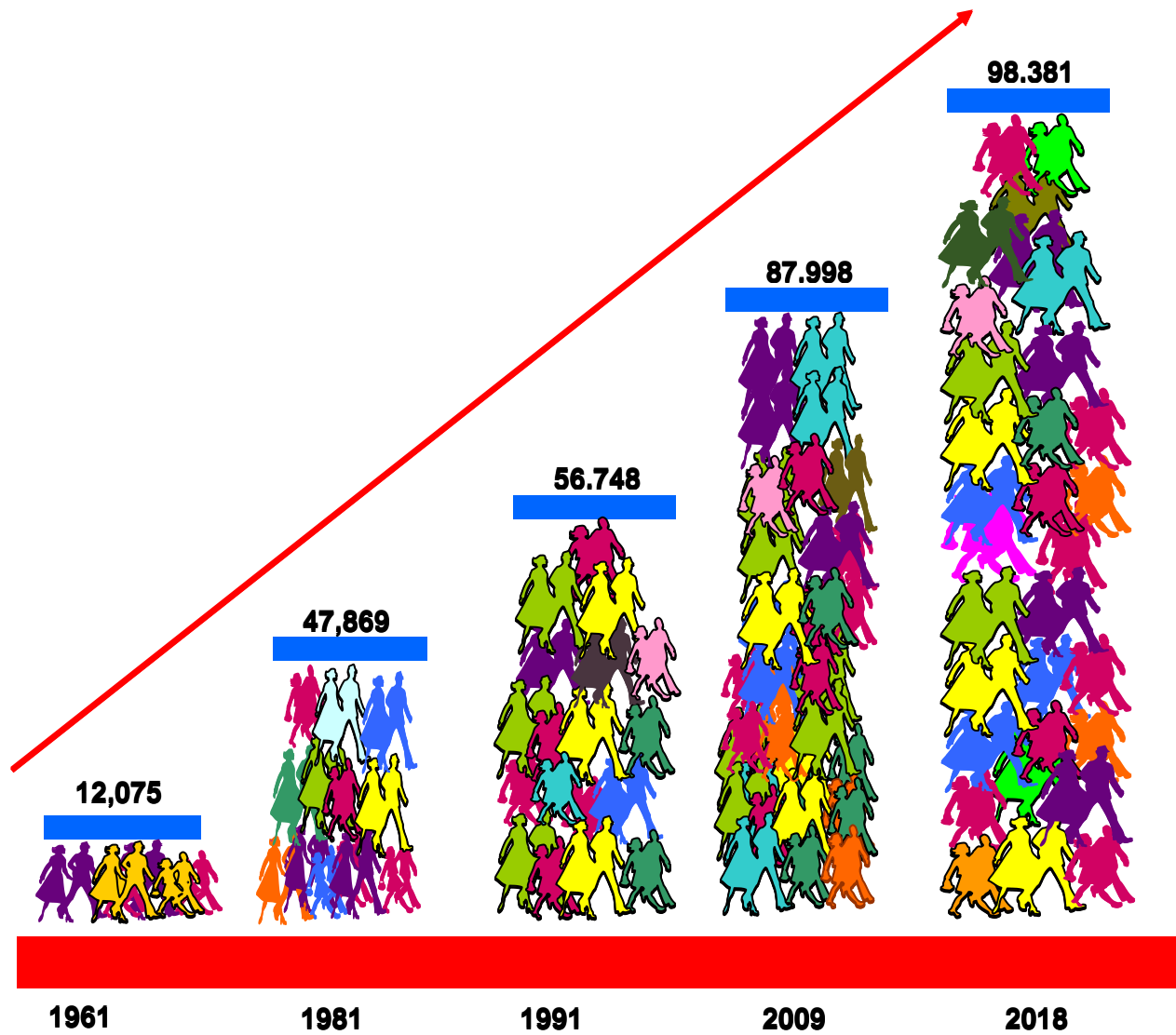

- Overall, of the 27,049 residents living in the Rural Service Area, 2,106 live in the 8 hamlets noted above. 17,908 live on country residential estates and 7,035 live on farms (which include Hutterite colonies).
- A visual depiction of the changing size of Strathcona County since 1961 is shown in Figure 3. It can be seen that the size of the County has increased dramatically since 1961. The County has more than doubled its size since 1981. Within the last 18 years (since 2000)³, it has increased in size by 42%.

³ In 2000, Strathcona County's official population was 69,268.

Population Growth in Strathcona County (1961 – 2018)

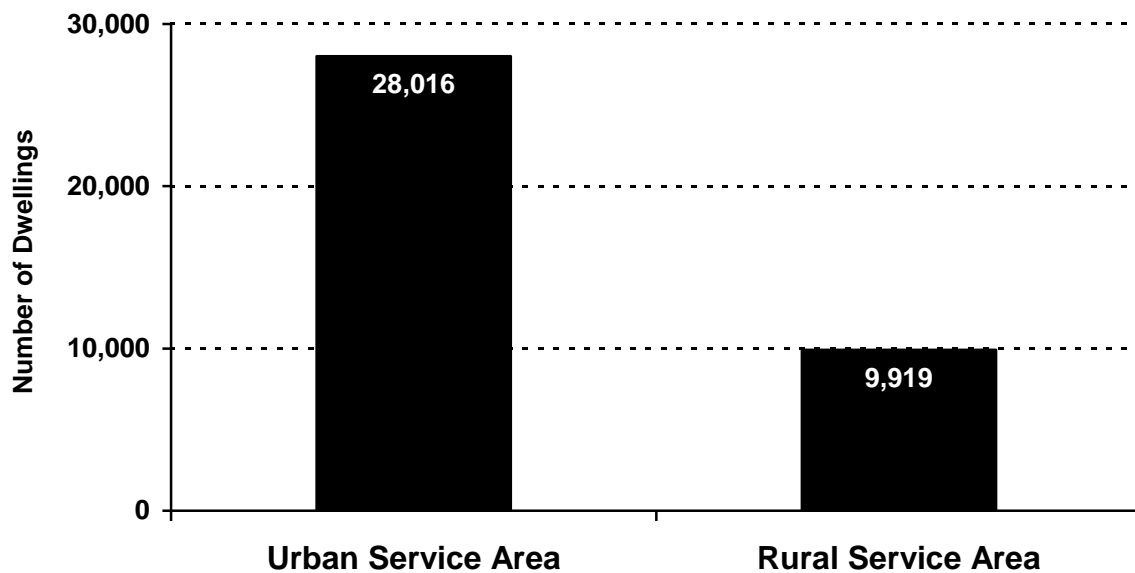


B. Household Statistics

Number of Dwellings

In 2018, the total number of dwellings in Strathcona County is 37,935. The total number of dwellings in the rural and urban portions of Strathcona County is depicted in Figure 4. The numbers shown in this figure is the combined total of occupied dwellings, vacant dwellings and dwellings that were under construction as of May 1, 2018.⁴

Location of Dwellings throughout the County

Census Highlights – Dwelling Location

- This table presents a breakdown of the number of occupied and vacant dwellings throughout Strathcona County as of May 1, 2018. The percentages in this table depict the percentage comparison of the number of dwellings in the urban and rural regions of Strathcona County. For example, of the 36,888 occupied dwellings in the County, the majority of them (N=27,340 or 74.1%) are located in the Urban Service Area.
- The other two columns depict breakdowns of the number of vacant dwellings and the number of dwellings under construction. The percentages add up to 100% in each column.
- The majority of dwellings that exist throughout the County are occupied. As seen in Figure 5 on the next page (and in Table 2 on page 9 of this report), it can be seen that for the County as a whole, 97.6% of the dwellings are occupied, 1.8% are vacant, and 0.6% are under construction. A breakdown for the Urban Service Area and the Rural Service Area can also be seen in Table 2.

⁵ It should be noted that during the data collection process, although guidelines were provided on how to classify a dwelling, individual judgment calls were often made by enumerators as whether a dwelling was “vacant” or “under construction.” In this regard, it is possible that some dwellings classified as vacant should instead have been classified as under construction, particularly in new neighbourhoods. There were also instances where enumerators may have classified properties that were under construction as “vacant lots” due to very little activity on the site. The number of vacant lots throughout Strathcona County is not included in our data calculations, but is available upon request.

(2018)

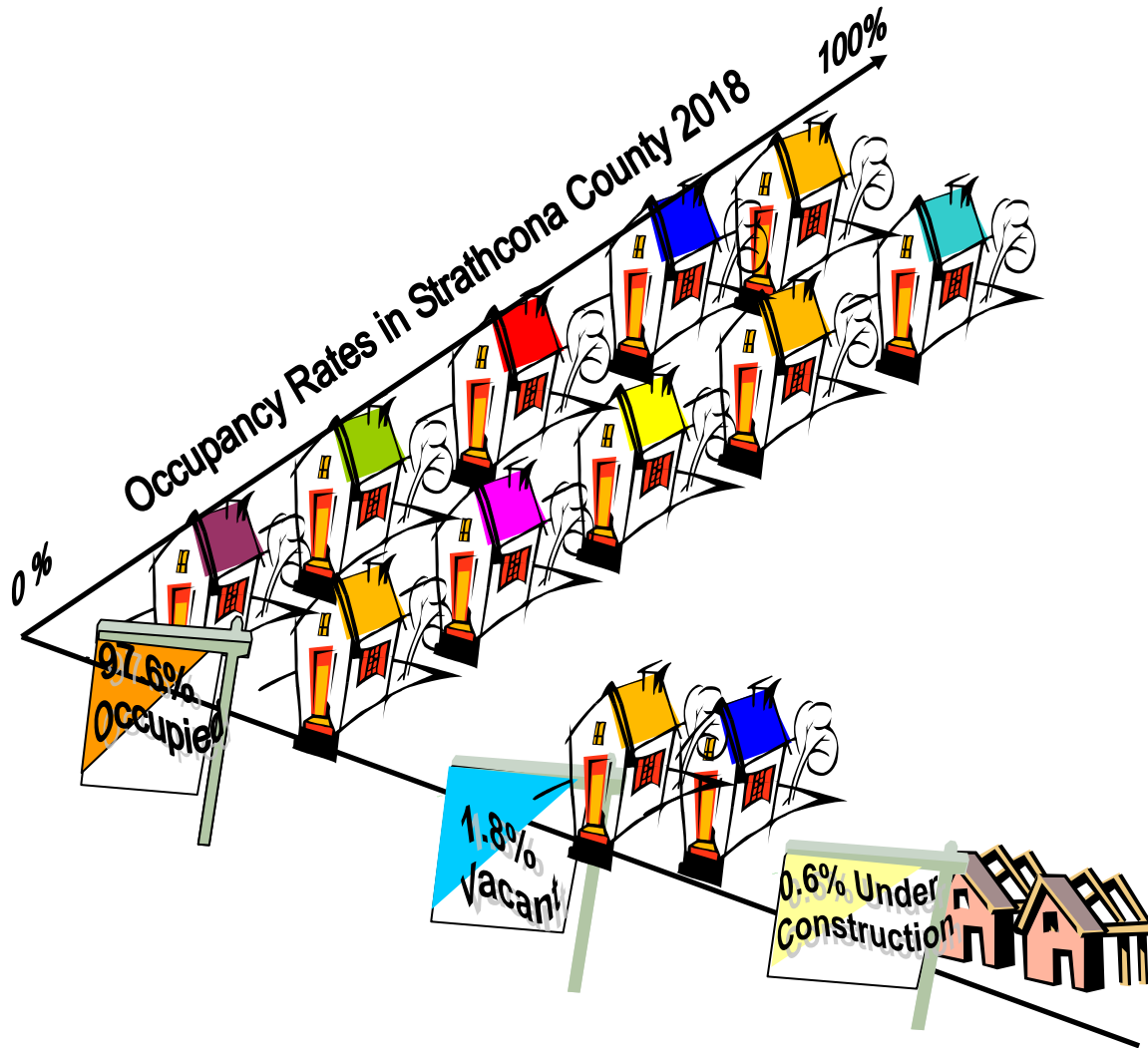

Census Highlights – Dwelling Location

- This table presents a breakdown of the number of occupied, vacant and dwellings under construction for the Urban Service Area, the Rural Service Area, and the total County. The percentages in this table depict a breakdown within each part of the County. For example, within the Urban Service Area, of all the dwellings, the majority (97.6%) **are occupied**, with a very small percentage either vacant or under construction. The percentage breakdown is very similar in the Rural Service Area as well.
- The other two columns in Table 2 depict breakdowns of the status of dwellings in the Rural Service Area and for the County as a whole.

Table 3 presents a breakdown of the status of dwellings within the Rural Service Area as of May 1, 2018.

Census Highlights – Dwelling Location within the Rural Service Area

- Within the rural parts of the County, dwellings can be located on farms, in a country residence or in a hamlet. For example, of the 9,548 occupied dwellings in the Rural Service Area, the majority of them (N=6,062 or 63.5%) are classified as country residences.
- The other two columns depict breakdowns of the number of vacant dwellings and the number of dwellings under construction within each type of rural classification.

Types of Available Dwellings

The type of dwellings available to people in Strathcona County is listed in Table 4, which include those dwellings that are vacant or under construction at the time of the census collection.

Census Highlights – Dwelling Types

- The majority of housing stock in all parts of Strathcona County is single detached dwellings.
- There are very few duplexes and apartments (and no row house developments) in any parts of the Rural Service Area. The majority of these types of dwellings are located in the Urban Service Area.

⁶ Collective dwellings include structures such as *nursing homes, senior citizen homes, Hutterite colonies and homes for challenged people (e.g. those with Alzheimer’s etc.)*. There are also a number of independent living apartments, where residents live in their own suite.

⁷ Please note that these totals exclude 49 dwellings in the Urban Service Area where enumerators were unable to definitively identify the type of dwellings that were under construction during the census.

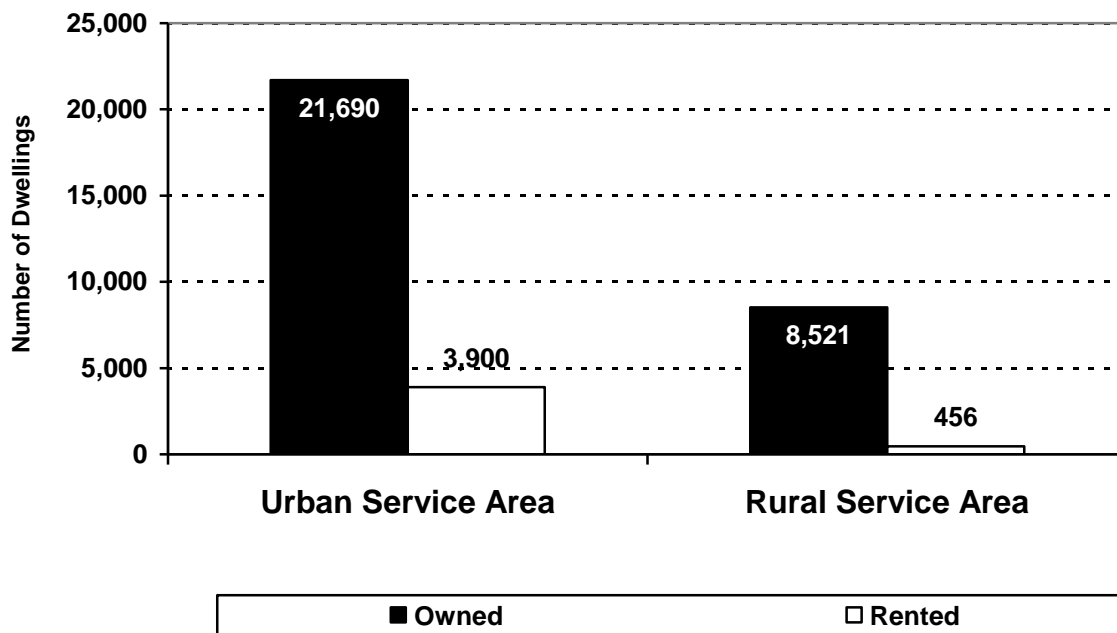

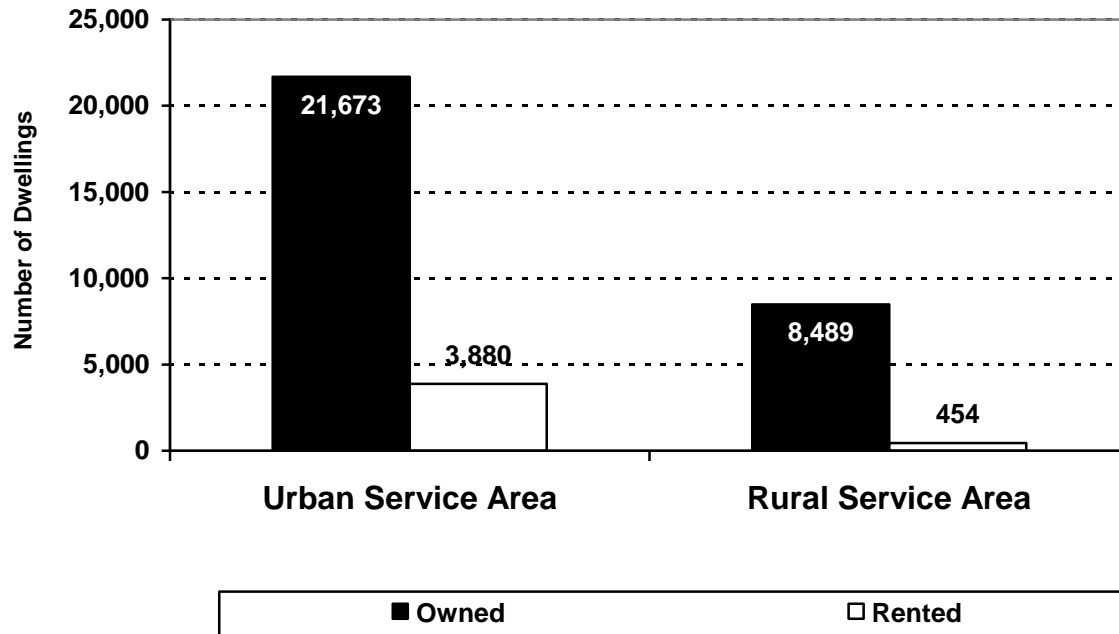

Census Highlights – Ownership Status of All Existing Dwellings

- Of the residents who provided information on ownership, it was found that the majority of dwellings in Strathcona County are owned (87.4%). This breaks down to an 84.8% ownership in the Urban Service Area and 94.9% in the Rural Service Area.
- With respect to the total number of dwellings, there were 2,447 instances where the ownership of a dwelling was not stated by the resident(s), which amounted to 8.7% of all dwellings in the County.
- A depiction of the number of occupied dwellings can be found in Figure 7 (on the next page of this report).

Ownership Status of Occupied Dwellings in Strathcona County (2018)



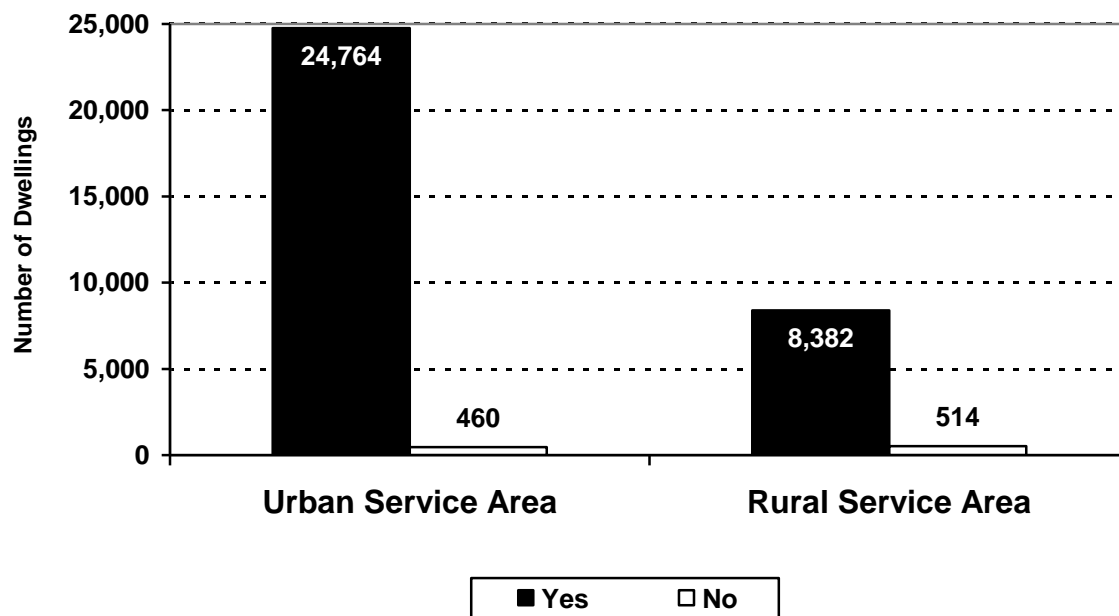
Census Highlights – Ownership Status of Occupied Dwellings

- Of the residents living in occupied dwellings in Strathcona County who provided information on ownership, the majority are owned (87.4%). This breaks down to an 84.8% ownership in the Urban Service Area and 94.9% in the Rural Service Area.
- With respect to the total number of occupied dwellings, there were 1,787 instances where the ownership of a dwelling was not stated by the resident(s).

Internet Access in Occupied Households

The number of households that currently have (or do not have) Internet access within their dwellings in the rural and urban portions of Strathcona County is depicted in Figure 8. Please note that those living in dwellings within the Urban Service Area who do not have Internet access have made a conscious choice not to have the Internet, as suppliers of the service are readily available in this geographic portion of Strathcona County.

Internet Access in Occupied Dwellings in Strathcona County (2018)

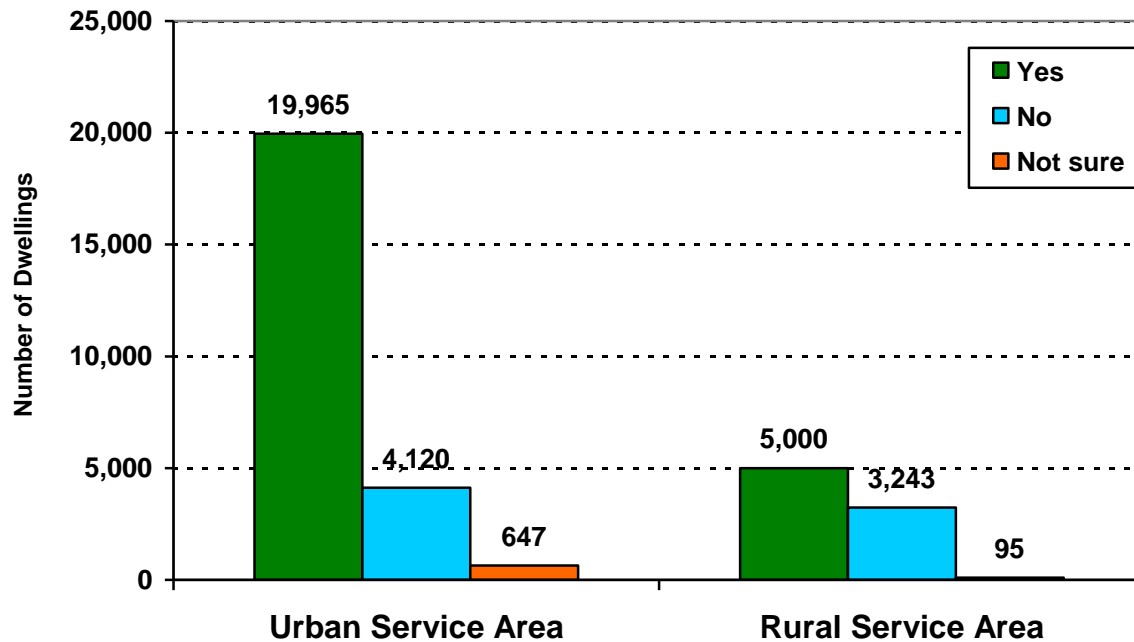


Census Highlights – Internet Access

- Of the residents living in occupied dwellings in Strathcona County who provided information on having Internet access, 33,146 households (97.1%) had an online connection. This breaks down to online access by 98.2% occupied households in the Urban Service Area and 94.2% in the Rural Service Area.
- With respect to the total number of occupied dwellings, there were 2,768 instances where the status of Internet access was not stated by the resident(s). This amounted to 10.4% of all occupied dwellings across the County where no information on Internet access was provided.
- A depiction of the satisfaction with Internet speed can be found in Figure 8 (on the next page of this report) by those households who indicated that they had an online connection.

Residents who had Internet access were then asked to indicate if they were satisfied with the speed of the Internet. The results are depicted in Figure 9. Please note that this data is based on perceptions that individuals have with their Internet service, and is not an indicator of the subscribed speed that they actually have.

Satisfaction with the Speed of the Internet Service in Occupied Dwellings in Strathcona County (2018)



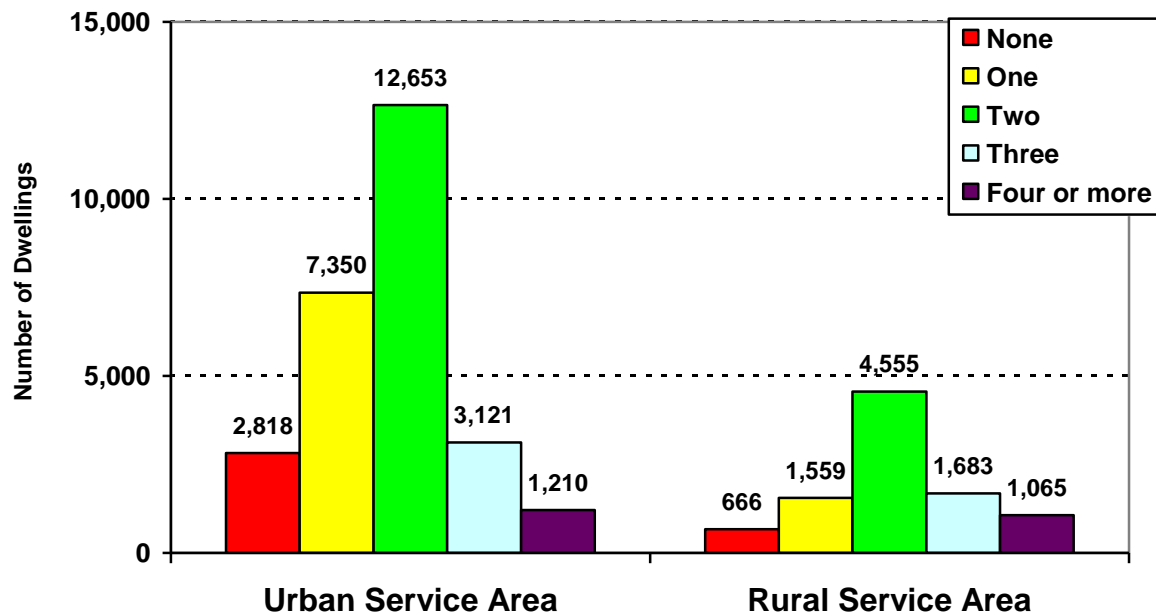
Census Highlights – Speed of the Internet

- It can be seen from Figure 9 that the majority of residents living in the Urban Service Area are satisfied with the speed of their internet connection. From a percentage perspective, 80.7% were satisfied, 16.7% were not, while the remaining 2.6% were not sure.
- With respect to residents living in the Rural Service Area, satisfaction with the speed of their internet connection was considerably lower. From a percentage perspective, 60% were satisfied, 38.9% were not, while the remaining 1.1% were not sure.
- This figure excludes 2,608 households from the Urban Service Area (9.5%) and 1,210 households from the Rural Service Area (12.7%) that did not answer this question – in most cases, this is because the household did not have an Internet connection.

Number of Vehicles

The number of vehicles owned by households in the rural and urban portions of Strathcona County as of May 1, 2018 is depicted in Figure 10.

Census Highlights – Number of Vehicles

- The majority of households in Strathcona County have two vehicles that are used daily (46.9%). This breaks down to 46.6% in Urban Service Area and 47.8% in Rural Service Area.
- It can also be seen from Figure 10 that there are households where no vehicles are owned. This breaks down to 10.4% in the Urban Service Area and 7% in the Rural Service Area.
- This figure excludes 188 households from the Urban Service Area and 20 households from the Rural Service Area that did not disclose information about the number of vehicles (if any) that were used by household members.

Household Size

Household size in urban and rural Strathcona County is broken down in Table 7.

Census Highlights – Household Size

- Percentages shown in this table add up to 100% by columns.
- The data presented in this table is based on occupied households that are classified as private households. A private household is defined as either a single person, a family with two or more persons, or a shared accommodation arrangement (e.g. two or more non-related people sharing a dwelling).
- This table includes those people living within *collective dwellings*. A collective dwelling refers to a setting that fulfills a particular purpose or function within the community, most often in some form of assisted living. For example, collective dwellings in Strathcona County can be nursing homes, senior citizen homes, or homes for physically or mentally challenged individuals. Hutterite colonies in the Rural Service Area are also classified as collective dwellings.
- In 2018, there were 489 occupied residences classified as collective dwellings in Strathcona County.⁹ The number of people residing within a collective dwelling range ranged from 1 person to 118 people. Of all the collective dwellings, 11 of

⁸Collective dwellings were not excluded from the numbers noted in this table.

⁹ 483 of the collective dwellings were in the Urban Service Area, while 6 were part of the Rural Service Area.

- these had 10 or more people residing in them. Many of the larger collective dwellings consisted of individual apartments where seniors lived independently.
- The average household size (excluding those living in *collective dwellings*) in the Urban Service Area is 2.61 people. Since in reality we cannot have a portion of a person living in a household, in the Urban Service Area, the median household size¹⁰ is 2 people.
 - The average household size in the Rural Service Area is 2.82 people. The median household size is 2 people.
 - A breakdown of household size within the Rural Service Area is as follows:
 - Country residential households have an average size of 2.95 people, with a median of 3;
 - Farms have an average size of 2.60 people, with a median of 2; and
 - Hamlets have an average size of 2.55 people, with a median of 2.
 - The reason that collective dwellings are excluded from the calculation of average household size is that the number of people in these settings is often large, and will distort the average household size figures.

¹⁰ The median is the middle score, or the 50th percentile point of the distribution of households. What this means is that 50% of the households in the Urban Service Area are above the median (or have more than 2 people), while 50% of the households are below the median (or have less than 2 people).

C. Individual Resident Statistics

Length of Residency

In 2018, residents were asked how long they have lived within Strathcona County. An overall breakdown of the length in time residents have lived in either the Urban Service Area or the Rural Service Area is shown in Table 8.

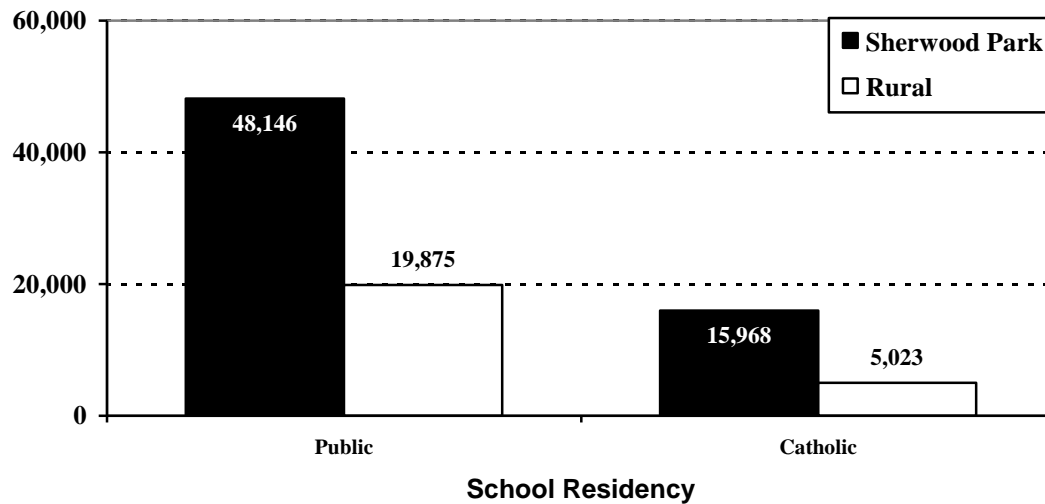
Census Highlights – Length of Residence

- The majority of Urban Service Area and Rural Service Area residents have lived in Strathcona County for 10 or more years.
- Percentages add up to 100% by columns. The percentage figures in Table 8 exclude those people whose length of residence was not stated.
- The length of residency for 8,278 residents was not reported. In the Urban Service Area, this information was not known for 6,285 people and for the Rural Service Area, 1,089 people.

School Support

The school support (faith) of Strathcona County residents for 2018 is shown in Figure 11 by location of resident.

School Support in Strathcona County



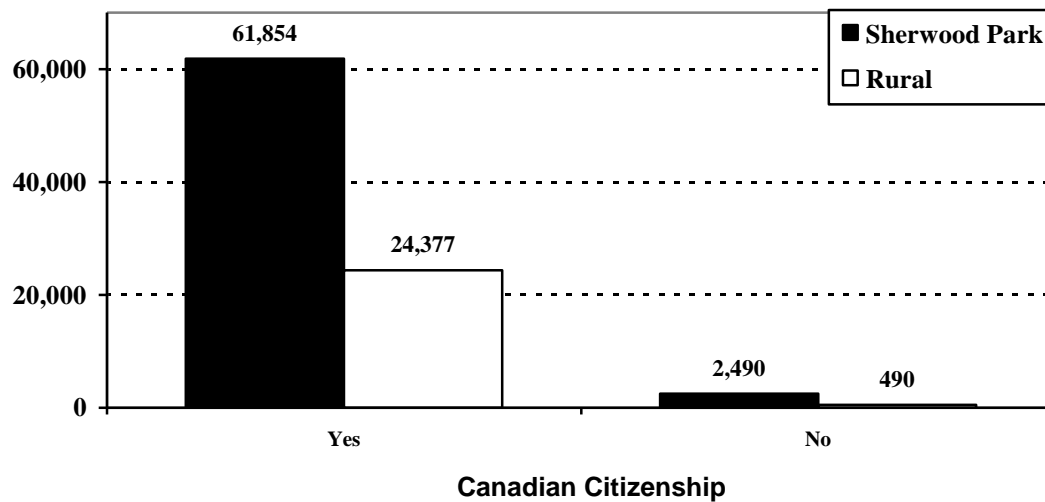
Census Highlights – School Residency

- This data is based on the type of school system supported by household residents.
- More residents support the public system over the Catholic system. For the County as a whole, 68,021 residents supported the public system, while 20,991 supported the Catholic system. School support was not stated by 9,369 residents.
- In terms of percentage comparisons of those who declared the school system for Strathcona County as a whole, 76.4% of school support was public, while 23.6% was catholic.

Canadian Citizenship

The Canadian citizenship breakdown of Strathcona County residents for 2018 is shown in Figure 12 by location of resident.

Census Highlights – Canadian Citizenship

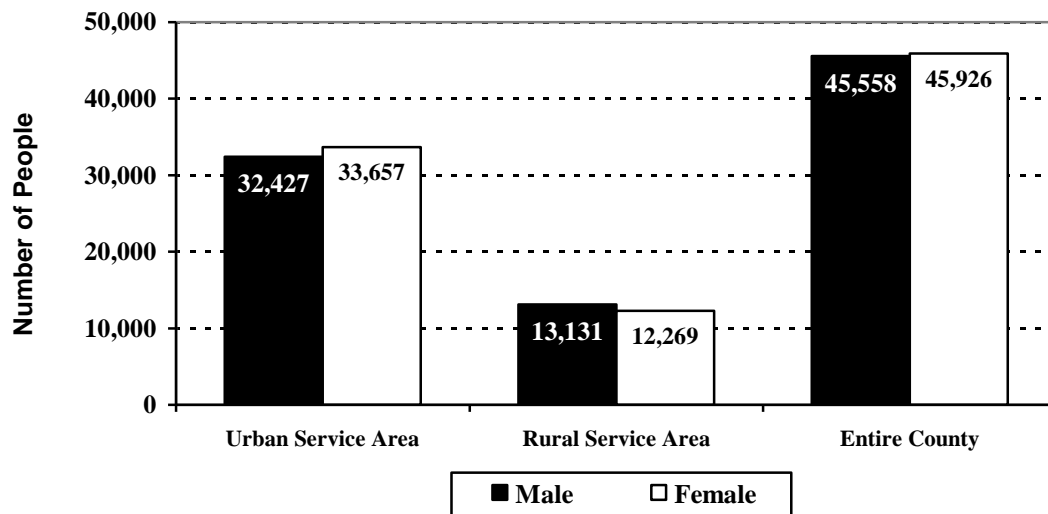
- Most residents in both the Urban Service Area and the Rural Service Area County are Canadian citizens. For the County as a whole, 86,231 residents are Canadian citizens, while 2,980 are not.
- Canadian citizenship status was not known for 9,170 residents.

Gender Comparisons

A breakdown of gender within the Urban Service Area, the Rural Service Area, and Strathcona County as a whole is shown in Figure 13.

Census Highlights – Gender



- There is a fairly even split of males and females in all parts of Strathcona County. There are slightly more males in the Rural Service Area and slightly more females in the Urban Service Area.
- There were also 43 instances where an individual chose to identify their gender as “other” throughout Strathcona County. Due to the small number of people that chose this classification, this data is not presented in this section of the report.
- In the Urban Service Area, there were 5,214 instances where the gender of a household member was not stated.¹¹ In the Rural Service Area, there were 1,640 instances where this information was not stated.

¹¹ These shortfalls are either due to circumstances where there was no one available in a household to interview or where limited information was provided during the census data collection period by residents. This is why the total of males and females is less than the total number of people noted earlier in this report. The same reason also applies to age and other demographic questions.

Age Comparisons

A breakdown of age within the Urban Service Area, the Rural Service Area, and Strathcona County as a whole is shown in Table 9.

Census Highlights – Age

- A percentage comparison of age groups between rural and urban Strathcona reveals a similar distribution across the County in most age groups.
- In 2018, the average age of Urban Service Area residents is 39.8 years, while the median age is 40. In 2015, the average age was 38.5 and the median age was 39. What this means is that in the year 2018, the population in the Urban Service Area is growing slightly older. This aging trend has been occurring for some time now.
- In 2018, the average age of people living in the Rural Service Area is 41.3 years, while the median age is 43. In 2015, the average age was 40 and the median age was 45. What this means is that in the year 2018, the population in the rural areas of Strathcona County is getting slightly older, much like the Urban Service Area.
- In terms of averages and medians derived in 2018, the people in the Rural Service Area are slightly older than those living in the Urban Service Area. This has been a trend for several years now.
- In this year's census report, there were 7,497 instances across Strathcona County where the age of a household member was not stated.

Census Highlights – Age by Gender

- Table 10 depicts a detailed percentage comparison of age groups by gender for the Urban Service Area. There are similar numbers of males and females within each age group with some minor exceptions. The main difference between the sexes can be seen within the 85 or older age category, where the females considerably outnumber the males. It should also be noted that 85+ age group has the smallest number of residents of all ages in the County.
- A further analysis revealed that the mean age for men in the Urban Service Area was 39.1 years, while the mean age for females was 40.6 years. Median figures show the age midpoint for males being 39, and females being 41 years. The mean ages for males and females are slightly higher than what was found in 2015. The median age for males is one year higher than it was in 2015, while the female median age is two years higher than in 2015.
- Table 11 depicts a detailed percentage comparison of age groups by gender for the Rural Service Area. With some minor exceptions, there are similar numbers of males and females within each age group.
- A further analysis revealed that the mean age for men in the Rural Service Area was 41.5 years, while the mean age for females was 41.1 years. Median figures show the age midpoint for males is 45 and females is 44 years. The mean ages for males and females are both slightly higher than what was found in 2015. The median age for males and females is one year higher than it was in 2015.

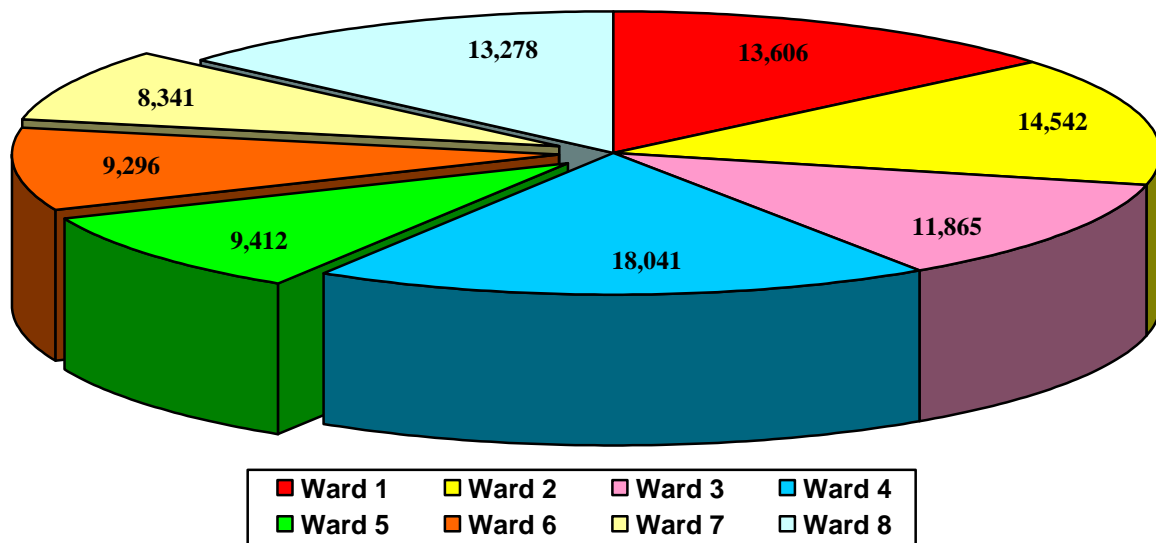
