

On May 21, 2019, the Bremner and LEA Area Concept Plan will be presented to Council for Public Hearing and first reading. If given first reading, it will then be submitted to the Edmonton Metropolitan Region Board. If approved by the Edmonton Metropolitan Region Board, it will be brought back in July 2019 for second and third reading.

The Public Hearing will provide an opportunity for members of the public to speak to Council on the proposed Area Concept Plan.
