# 2015 Strathcona County Directions Survey Report




## **Strathcona County Survey Council Priorities, Programs, and Services**

In the spring of 2015, Strathcona County citizens were asked to complete a very short, interactive survey regarding awareness of Council's strategic plan and priorities. The survey, called SC Directions, provides a baseline of awareness of residents on the County's Strategic Plan, as well as priority-based business planning and budgeting. The survey also had an educational component in informing citizens on the items the survey asked.

Surveys were complete either online through the Strathcona County website, or through iPads at various events and County locations. It was deemed a very successful survey, with 1,349 people answering at least one question.

## Part 1: Perceptions of What Constitutes a Livable Community

Residents were given the opportunity to pick up to 3 different categories out of eight possible choices that defines for them what makes a "livable community" to them.





Question 3: Did you know that Strathcona County is implementing a new way of planning and budgeting based on priorities?



Survey Responses to Council-Prioritized Goals




These results show that residents differ in their perceptions of what priorities should tackled first, compared to what Council perceives to be the top of the list.

Question 5: Do you have the information you need on County priorities, programs, and services?




Question 6: Where do you like to get information on County priorities, programs and services? Select all that apply.



Residents were asked the level of importance that residents had for Strathcona County to keep people informed about the progress on the County's strategic plan.

Question 7: How important is it to you that Strathcona County keeps you informed about the progress on the County's strategic plan?



Please note that the above percentage excluded 210 residents who did not provide an opinion on this question.

#### **Part 3: Conclusion**

The 93.4% of residents indicated that they preferred doing surveys online rather than telephone surveys.

42.9% of people, or 579 respondents, were willing to take part in future online surveys and provided their email addresses.

#### **Next Steps**

These results will be used to develop an education campaign to increase residents' awareness of the County's Strategic Plan and priority based business planning and budgeting. The education campaign will be launched in late 2015 and continue throughout 2016.

Citizens will be asked to complete a similar survey in 2016 which will help in the development of the 2017 and 2018 public engagement process. This process will support Council in reviewing the strategic goals for 2019 – 2022. Council's priorities will inform the second iteration of the Corporate Business Plan and Budget (2019-2022).
